Objective and Rationale The REIT Manager prepared HREIT Trust's financial statements in

accordance with the accounting standard and audited by the auditors, the

detail of which appeared in the annual report for the year 2018 Annex 2. The

significant details are summarized as follows:

Balance Sheet as of 31 December 2018

HREIT Trust has the total assets in amount of approximately Baht 9,691.37

million and the total liabilities in the amount of approximately Baht 3,510.55

million. The net asset value is approximately Baht 6,180.82 million. The

equity from the Trust Unitholders is in the amount of Baht 6,062.43 million,

and the retained earnings is the amount of Baht 118.39 million.

Income Statement for the period from 1 January to 31 December 2018

HREIT Trust has income in the amount of approximately Baht 726.04 million

and expenses in the amount of Baht 81.15 million. Therefore, HREIT Trust

has the net income before financial costs and net gain from investment in

the amount of Baht 644.89 million. After deducting financial costs in the

amount of approximately Baht 117.98 million, and additional net gain from

investments in the amount of Baht 123.21 million (out of which Baht 122.50 million is the net unrealized gain from investment valuation) from the said

net income, HREIT Trust has the increase in net assets from operations

during the year (net gain) in the amount of approximately Baht 650.12 million

Whereby, one of the aforementioned persons shall review and give their opinions to HREIT Trust's financial statements. In case such auditors cannot perform the work, Pricewaterhouse shall provide other certified public accountants in Pricewaterhouse to carry out the work. The remuneration of the auditors for the year 2019 is Baht 970,000 (exclusion of other expenses). The remuneration is for auditing the annual and quarterly financial statements.

The REIT Manager considered it appropriate to propose the Trust Unitholders' meeting to acknowledge the appointment of the auditors for the year 2019 as named above.

Independent Director, namely Mr. Phorntep Rattanataipop or other persons to attend the meeting and vote on their behalves. The REIT Manager would like the Trust Unitholders to bring the documents and evidence of giving proxy as detailed in <u>Annex 4</u> to the registration officer on the date of the meeting.
